### **Commissioner of the Year Nomination**

Commissioner of the Year is open by nomination to recognize a Commissioner who has made an outstanding contribution to the Housing or Community Development field on the local or state level.

*Supporting Document Requirements: Attach name of nominee and agency information along with a brief narrative on the achievements you feel are worthy of this recognition.*

### **Agency of the Year**

Meritorious accomplishment by a housing agency, community development department/agency This award seeks to honor agencies for specific accomplishments or contributions to housing and community development.

*Supporting Document Requirements: Attach agency information along with a brief narrative on the achievements you feel are worthy of this recognition.*

### **Horses Aft Award**

The "Horse's Aft" is presented annually to an individual or group who during the past year (or recent years) has committed (or been the victim of) a blunder, miscue, or series of blunders or miscues related to our professions and programs. Nominations (brief, informal and SECRET) recounting the incident(s) must be sent to the Service Office or the Chair of the Award
